The client agrees to the uploading to the VZ Financial Portal of the data for all current and future services provided to the client. The client acknowledges and agrees that the user may have access to all of the client's services which have been activated. If the client wishes to impose special restrictions on the user in relation to the services, he/she may contact his or her client advisor.



3. Authorisation to access banking services (please tick as desired)

5. Non-binding status of mortgage data

The client acknowledges that any mortgage data stored on the VZ Financial Portal are legally non-binding and are provided solely for information purposes. Particularly in the case of adjustments to the mortgages, uploaded data may not be in conformity with the agreed terms.

Irrespective of the mortgage data published on the VZ Financial Portal, the agreed mortgage terms and conditions shall in any event remain legally binding.

6. VZ documents

The documents provided by VZ (such as, for example, credit notes, reports, etc.) shall be made available to the client in electronic form on the VZ Financial Portal. This does not apply to documents that are not electronically available or where hard-copy delivery is required by law:

The client would also like to receive the tax documents in hard-copy form.

The client would also like to receive quarterly reports on his/her custody accounts in hard-copy form.

7. Special provisions

For account/custody account relationships for which an asset management mandate exists, the user can only be given «query» authorisation.

It is the client's responsibility to inform the user of the content of the access authorisation granted hereunder and to ensure that the user complies with all obligations arising out of this application. The client acknowledges in advance all actions of the user in connection with this application as correct and legally valid and grants VZ a full discharge in respect thereof.

This access authorisation shall remain in force until such time as the bank receives written notice of revocation. Revocation of a limited power of attorney on the client's signature documents deposited with the bank does not automatically result in the revocation of this access authorisation, but rather this shall require a separate written notice of revocation. The access authorisation granted hereby shall not expire in the event of incapacity, declaration of presumed death or death of the client.
